#### **1. INTRODUCTION**

The board of directors of UG Healthcare Corporation Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) refers to the announcements released by the Company on 31 August 2020, 16 September 2020 and 18 September 2020, and the circular dated 3 September 2020 (the “**Circular**”) in relation to the proposed share split of every one (1) existing ordinary share in the capital of the Company into three (3) ordinary shares (the “**Share Split**”). *Unless otherwise defined, all capitalised terms used herein shall have the same meanings ascribed to them in the Circular.*

The Share Split was duly approved by the Shareholders at the EGM of the Company held on 18 September 2020.

#### **2. NOTICE OF SHARE SPLIT RECORD DATE**

**NOTICE IS HEREBY GIVEN** that the Register of Members and the share transfer books of the Company will be closed on 1 October 2020, at 5.00 p.m. (“**Share Split Record Date**”) for the purpose of determining the shareholdings of the Shareholders pursuant to the Share Split and updating of the Register of Members pursuant to the Share Split.

Shareholders registered in the Register of Members and whose securities accounts with the Central Depository (Pte) Limited are credited with Shares as at the Share Split Record Date will be included for the purposes of the Share Split. Accordingly, every one (1) Share registered in the name, or standing to the credit of the securities account, of a Shareholder (as the case may be) as at the Share Split Record Date will be split into three (3) Shares.
